Our clients range from local and offshore financiers to major corporations that enter into local and offshore finance transactions.



DEBT CAPITAL MARKETS

We have a dedicated Debt Capital Markets team that works on all aspects of debt capital markets. The team has worked on both local and international issues, particularly sovereign debt issues and the impact of Basel III.

Commercial paper programmes and private placements – advising issuers, debt sponsors, arrangers and lead managers in relation to stand-alone bond and note issues, as well as in relation to the establishment of domestic medium-term notes (DMTN) and commercial paper programmes, the issue and listing of bonds and other types of notes and commercial paper under such programmes on the Interest Rate Market of the Johannesburg Stock Exchange.
